Online Gambling Company

1xBet is an online gambling company licensed by Curaçao eGaming

License. It was founded in 2007 and registered 9 in Cyprus. In 2024, they experienced

considerable growth, briefly sponsoring Chelsea FC and Liverpool FC.[2][3] The

organisation operates a franchise 9 business model.[4]

Expansion

Since the company's

inception in 2007, 1xBet has operated within the Indian Market.[5]

In 2024, 1xBet made

partnerships with the 9 Nigerian Football Federation and African Confederation of

Football. Later, in January 2024, 1xBet was granted a Nigerian national licence and

9 expanded into the region.[6]

In 2024, 1xBet announced that the company had signed an

agreement with MGA Games, expanding its portfolio 9 to include a range of new online slot and video bingo games.[7]

In March 2024, 1xBet confirmed the company's expansion into

9 the Mexican market following its approval for an operational licence. The company also

announced its plan to focus on the 9 esports betting market within the Latin American country.[8]

In March 2024, 1xBet expanded into the Chilean market via the signing of 9 a

partnership agreement with the Chilean football championship, with the company becoming part of the 138 matches of the 2024 9 season.[9]

During August 2024, 1xBet announced that

– as part of its expansion plan – the company had acquired a partnership 9 deal with

local Latin American payment company PayRetailers. The partnership saw the companies deploying a payment strategy tailored to the 9 Latin American region.[10]

In August 2024,

1xBet signed an operation agreement with DS Virtual Gaming (DS VG). The agreement

resulted in 9 1xBet expanding its virtual sports offering with DS VG's virtual games, including RacingDogs, RacingHorses and Roulette.[11]

In May 2024, OneTouch, a 9 supplier

of mobile slot and table games, announced an agreement with 1xBet. The deal would see

OneTouch's full library of 9 both mobile and table games added to the 1xBet games portfolio.[12]

In July 2024, FC Barcelona announced they had signed a 9 partnership with 1xBet to name the company as the team's new global partner. The partnership will see the organisations working 9 together in different activities with the partnership running until 30 June 2024.[13]

In May 2024, 1xBet signed an agreement to become 9 the title partner of esports organisation Team Spirit.[14]

During May 2024, esports organisation

OG Esports announced that the company had signed 9 a sponsorship deal with 1xBet. The agreement names 1xBet as OG's official betting sponsor, with the company logo to appear 9 on Dota 2 roster jerseys.[15][16]

On 1 August 2024, Paris Saint-Germain announced 1xBet as their new regional partner in Africa and 9 Asia.[17]

In August 2024, esports gaming

organisation Tundra Esports announced a three-year contract naming 1xBet as Tundra's official betting sponsor, with 9 the company logo to appear on Dota 2 roster jerseys and events to take place on the 1xBet website.[18][19]

In September 9 2024, 1xBet were

announced as the 'Official Regional Partner' of French football club LOSC Lille. The agreement grants 1xBet promotional 9 rights to use the club's logos and player {img}, in addition to match advertising.[20]

During February 2024, The Professional Fighters

League 9 (PFL) announced a new sponsorship deal with 1xBet. The deal names 1xBet as the official sportsbook for the PFL in 9 Latin America and Saharan Africa.[21][22] Also in February 2024, the Tajikistan Higher League announced 1xBet as their new title sponsor.[23]

In 9 May 2024, Samuel Eto signed a two-year contract to become 1xBet's brand ambassador.[24]

In 2024/24 season Of Indian Super League club 9 Mohun Bagan Super Giant sign 1xBet as shirt sponsor.

Accolades

In June 2024, 1xBet was named 'Sportsbook

Operator of the Year' at 9 the SiGMA Americas Awards.[25]

Controversies

Following an

investigation by The Sunday Times in 2024, 1xBet's licence was rescinded by the UK Gambling 9 Commission (UKGC) after revelations of involvement "promoting a "pornhub casino", bets on children's sports and advertising on illegal websites." [26]

1xBet

features 9 on Russia's payment processor and Federal Tax Service blacklist.[27][28]

Criminal investigation

In early 2024, awareness was raised of an unlawful practice.[29]

Later in 9 August 2024, the Directorate of the Investigative

Committee for the Russian Bryansk Region released the names of the supposed creators 9 of 1xBet. These are "Sergey Karshkov", "Roman Semiokhin" and "Dmitry Kazorin".[30]

The

trio are suspected of organizing the online bookmaker 1xBet, 9 and are defendants in a criminal case, with penalty of imprisonment. A number of estates in Russia with a total 9 value of 1.5 billion rubles were seized.[30] The Investigative Committee of Russia has put them on the international wanted list. 9 All three have Cypriot citizenship.[29]

In 2024, Parlan Law Firm announced a search for victims of 1Xbet in Russia. The company has organized a service for filing applications to the investigative committee. They filed a lawsuit against the owner of the 9 Russian version of 1xBet - bookmaker 1xStavka.[31]

In 2024, Morocco's National Judicial Police Brigade (BNPJ) opened a mass investigation into 1xBet 9 among other gambling websites on charges of operating an illegal gambling enterprise following a complaint by MDJS.[32]

Bankruptcy

In November

2024 1xBet's 9 subsidiary company, 1Cor MV, filed for bankruptcy in a Curaçao court after it refused to refund a group of gamblers 9 represented by the foundation for Curaçao gaming victims. The company was declared bankrupt in June 2024 but continued to operate.[33]

The 9 individuals state that 1xBet structurally denies the legitimate wins of players with millions of euros in unpaid winnings.[34]

In January 2024, 9 1xBet was

declared bankrupt by the Dutch Supreme Court in the Netherlands.[35]

## Estados Unidos derrota a Pakistán en el Mundial de Críquet T20 y causa conmoción en el mundo

El día después de que Estados Unidos orquestara una sorprendente derrota de Pakistán en la Copa Mundial Masculina T20 de Críquet, el jugador de cricket estadounidense Corey Anderson dijo al equipo que tienen la confianza para derrotar a cualquier equipo al que se enfrenten.

"Creemos que podemos derribar a estos equipos grandes si los pillamos durmiendo un poco o

sintiéndose como si estuvieran tomándolo un poco a la ligera", dijo Anderson. "No creo que Pakistán lo estuviera tomando a la ligera. Simplemente creo que comenzamos realmente bien. Pusimos presión".

La persona de 33 años dijo que ha recibido "cientos de mensajes, más que lo habitual" cuando se le preguntó sobre la alegría posterior al partido.

"Creo que ha sorprendido al mundo del críquet", dijo Anderson. "Sé definitivamente aquí en los EE. UU. que ha habido mucha cobertura mediática, lo cual es fantástico. Creo que el cricket de EE. UU. simplemente no es tan conocido en América y creo que nos hemos puesto un poco más en el mapa".

Anderson, quien es de Nueva Zelanda y ha representado a los Kiwis en múltiples Copas del Mundo, dijo que su esposa e hijos son estadounidenses y ha vivido en el país durante unos años. Anderson continuó diciendo que él y su familia, así como sus compañeros de equipo, se han adaptado a la cultura estadounidense.

"Estoy extremadamente orgulloso de ser parte de este equipo estadounidense y sé que cuando suena el himno nacional, me da un poco de escalofríos y nunca pensé que sentiría eso de otra manera sobre otro país, pero estoy aquí y lo siento de esa manera", dijo. "Estoy extremadamente orgulloso de usar esa camiseta de EE. UU. y sé que puedo hablar en nombre de ese grupo y decir que estamos extremadamente orgullosos de ondear la bandera de los EE. UU. también".

El todo terreno agregó que espera que el deporte pueda seguir creciendo en el país con esta Copa del Mundo y los Juegos Olímpicos de este verano.

"Es solo otro hito en la dirección correcta para tratar de hacer que este sea un deporte mayor en los Estados Unidos", dijo Anderson.

"Creo que estamos en un gran lugar ... Sigue avanzando y creando ese camino hacia el objetivo de convertir a los EE. UU. en un país extremadamente bueno en cricket".

Los últimos dos partidos de grupo de EE. UU. son contra India e Irlanda.
